**H2017/055 Minutes of the meeting held on 13<sup>th</sup> February 2017**

It was proposed by Councillor G Jones and seconded by Councillor R Higginson that the Minutes of the last meeting be agreed as a true record and signed by the Chairman.

**H2017/056 Matters Arising**

**Post Box, Bayley Hills House, High Street**

Councillor Higginson updated Members on his enquiries to date. He will continue to investigate the options available and will report back to the next meeting.

**Redundant Grey Royal Mail Boxes**

Councillors R Higginson and G Jones will attempt to remove the boxes from Chetwynd Road, Shrewsbury Road and there may also be one in Pipers Lane.

**H2017/057 Street Lighting**

The survey by EON, due in March of this year, has still not been completed. The Clerk will enquire of EON when this is likely to be done. This would result in information being available for the Council to consider the purchase of more reconditioned LED lights.

Councillor Hughes agreed to undertake a further tour of the Parish and to provide details of any defective lights.

The hedges are still covering lights at The Priory and Edmond Villa, these would be reported to EON.

**H2017/058 Highways and Road Safety**

The issue of overgrown trees and hedges causing visibility problems for road users and pedestrians will be included on the website and in a future magazine, asking residents to cut back hedges wherever possible.

Concerns over speeding traffic, this includes agricultural vehicles, continue to be received from the local community. This will be raised at the next Liaison Meeting with Dominic Proud and wherever necessary registration numbers can be reported to the police.

Consideration of a 20 mph limit will be on a future agenda.

HGVs and tractors are causing further damage to roads and verges – the question of police support and action against speeding traffic will be asked of John Campion when he attends a future Forum meeting. Many drivers can still be seen using mobile phones. The Clerk will enquire when the signs, included in the survey report sent to TWC, will be replaced and repaired.

The white-lining programme will be in Edmond, any areas in need of re-painting should be reported to the Clerk as soon as possible.

Footpath repairs are needed in Shrewsbury Road and on the B5062 and should be added to the list.
