18/1452 WELCOME AND PUBLIC SESSION

The Chairman, Councillor Higginson, welcomed everyone to the Full Council meeting and thanked them for attending.

ARRIVA 519 SERVICE - SHREWSBURY TO NEWPORT

Arriva had announced that the Monday to Friday service would continue for the time being, although they had stopped the Saturday service on 1st September. This had been a commercial decision based on funding and usage.

The week day bus is essential, particularly for schools, colleges, the University and work. It is also the only way some residents can access appointments, leisure and shopping trips.

Whilst the decision regarding the weekday services is welcomed, there remains a need for the Saturday service. Members were informed that Shrewsbury College are in favour of supporting the need for the 519.

a) Report

Councillor Jones presented the Minutes of the meeting held on 9th August, for information.

Permission had been granted to fell the three conifer trees, but only if permission is granted by the Landowner.

Members commented that the process is open to abuse and not in the best interests of The Conservation Area.

18/1460 ENVIRONMENT & RIGHTS OF WAY COMMITTEE

a) Report

No meeting had taken place.

b) Rights of Way

The signposts and way markers are now available and will be stored in Waters Upton. CE and KA offered to assist with the collection and installation of the posts when convenient with volunteers and the Ramblers.

c) Overgrown Hedges

Further concerns were expressed that hedges, particularly those on boundaries which cause visibility issues for pedestrians and drivers, are left uncut and are allowed to become too overgrown. The Parish Council will have no alternative but to report such addresses to the authority who will insist on action.

d) Shrub bed maintenance

Volunteers will meet on 6th October at 9.30am to undertake some essential maintenance on the beds near to Shrewsbury Road Car Park.

e) Shrewsbury Road Car Park and use of the sports field and pavilion

A meeting is to take place with TWC and a local football club regarding future use of the field and pavilion and a possible grant application to upgrade and enhance the facility and car park.

18/1461 HIGHWAYS, TRANSPORT & STREET LIGHTING COMMITTEE

a) Report

No meeting had taken place.

b) Community Speedwatch

Councillor Wilson updated Members on the scheme and presented a breakdown of the results from the sessions in August. 77 vehicles had been identified as travelling in excess of 35mph on Marsh Road, an average of 37.8mph. The Parish Council is working with West Mercia Police and some letters will be sent to those identified as 'speeding'.

A request to consider rumble strips in Marsh Road had been received. A full consultation would be required as these can be intrusive and detrimental to the quiet countryside.

c) Sign Audit

Councillor Wilson circulated a copy of the full sign audit, which had been produced following the full parish audit and meeting with TWC Highways Engineer.

A Highways Meeting will take place on 25th September where more information will be available.

d) Street Lights

One- off faults continued to be repaired as the contractor is in the area. However, the project to continue to upgrade the lights will be discussed further on 25th September.

e) Marsh Road, Edgmond

Detailed information regarding the weight restriction on Marsh Road had been obtained from West Mercia Police. The scheme was introduced to dissuade HGVs from using the road as a short cut from the A41 to B5062. Due to the sensitivity of the information, Councillor Wilson will engage with the residents to explain this in more detail.

f) Other Matters

Further information had been obtained regarding tractors, their size and speeds at which they can legally travel.

A dropped kerb will be requested to lead from Shrewsbury Road Car Park to the path towards the Bowling Green.

The car park surface continues to deteriorate and needs urgent attention.

Members were disappointed that the promised work on the walking us route has not yet been undertaken.

18/1469 MATTERS FROM TELFORD & WREKIN COUNCIL

Councillor Stephen Bentley reported on the work he, and Councillor Burrell, had undertaken and meetings attended regarding essential bus transport for a Newport to Shrewsbury route. North Shropshire Wheelers are to introduce a regular service from High Ercall to Newport and back. This will enable local residents to use Newport for appointments and shopping and to link them to other services, such as to Telford or Stafford.

Meetings with Arriva had identified a cost for the re-introduction of the Saturday service. Around 9000.00 will be required and Newport TC and Parish Councils will be asked to contribute towards the cost. Newport Regeneration Partnership will be approached along with HAU. It is then hoped that TWC will match fund what is achieved. Further information will be circulated as it is received. In the meantime, usage is essential if the service routes are to be maintained past May 2019.

18/1470 PARISH MATTERS

a) Mud on the Roads

It is important that tractor drivers and farmers are reminded of the law with regards to leaving mud on the roads. This can be dangerous if not cleared up. Thanks are extended to HAU whose drivers do clear the roads. The mud also damages the road surface and can result in more potholes.
