<p><b>Sponsorship</b> Any payment or provision of any other financial benefit (other than from the Council) made or provided within the relevant period<sup>3</sup> in respect of any expenses incurred by you in carrying out your duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</p>	<p>N/A</p>
<p><b>Contracts</b> Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest<sup>4</sup>) and the Council — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.</p>	<p>N/A</p>



<p><b>Land</b> Any beneficial interest in land<sup>5</sup> which is within the area of the Council.</p>	None
<p><b>Licences</b> Any licence (alone or jointly with others) to occupy land in the area of the Council for a month or longer.</p>	N/A
<p><b>Corporate tenancies</b> Any tenancy where (to your knowledge)— (a) the landlord is the Council ; and (b) the tenant is a body in which you or your partner has a beneficial interest.</p>	N/A
<p><b>Securities</b> Any beneficial interest in securities<sup>6</sup> of a body where— (a) that body (to your knowledge) has a place of business or land in the area of the Council ; and (b) either— (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>	N/A

**NOTES ON SENSITIVE INTERESTS**
